BOARD GOAL SETTING SESSION

Ms. Fallon shared notes she gathered from the Board Members about their suggestions for Board Goals, as attached.

Board Goal 1 - The Board discussed communication and that this is a priority goal.

Board Goal 2 - The Board discussed hiring a Superintendent and the hiring process.

The Board reviewed negotiations as a goal and decided to put a hold on this at the moment.

The Board discussed and decided a Strategic Plan is already underway and there is no need to make it a goal.

The Board agreed that demographics should be a District Goal.

The Board agreed to move Board Communication policy and procedures to the communication goal. The Board discussed always having an Administrator at the Board Meetings. Dr. Ruberto clarified that the Superintendent is the Administrator at the meeting. She then re-explained the Committee process. Dr. Ruberto suggested adding concerns to the communication as a goal.

Board Goal 3 - The Board discussed their concerns for Board leadership. They discussed a new goal that establishes a Board Governance Committee to define leadership and norms for the Board. They continued the discussion regarding the need to change leadership on the Board.

The action plans will next be created to address the three goals. The Board's consensus was received for the three goals.

Dr. Ruberto reviewed her preliminary District Goals. She will craft her suggested goals and will send them to the Board taking the attached notes into consideration. She noted the Special Education Department, the district climate and the need to analyze data, as District Goals.

On the motion of Ms. Borucki, seconded by Ms. Abbott, the meeting was adjourned, unanimously viva voce, at 6:45 p.m. to Executive Session in the Media Center.

SUPERINTENDENTS REPORT

Dr. Ruberto thanked the Administrators and support staff for their hard work over the summer. She then introduced the new District Administrators, Dr. Kathleen Giordanella, Interim Director of Special Education, Ms. Vanessa Ahmed, Principal, Copper Hill School, Ms. Katherine Griffith, Interim Vice Principal, Copper Hill School, Ms. Kristen Wolff, Supervisor of Math/Science, Ms. Kathryn Lemerich, 12 Month Vice Principal, Reading-Fleming Intermediate School, Mr. Anthony Giarratano, 10 Month Vice Principal, Reading-Fleming Intermediate School, Ms. Amy Switkes, Vice Principal, Barley Sheaf School and Mr. Ernest Batha, Interim Vice Principal, Reading-Fleming Intermediate School. She noted new teacher orientation took place today and a meet and greet with Ms. Ahmed at Copper Hill also took place today. She started her building inspections and gave an enrollment update. She also stated she will be looking at ways to balance class sizes. She noted the Policy Committee met and then explained the new Residency Inspector per diem, position being requested. Dr. Ruberto noted the School Security Plans were updated as were the Coaches manual. She is hosting a Realtors meeting on September 18th. She noted Mr. Masessa finished the Affirmative Action plan. She also noted the new Interim of Special Education and the Supervisor will be housed at the Copper Hill School. Dr. Ruberto shared that AED training has been given to the Response Teams in each school as well as all Physical Education Teachers, Coaches, at least 1 Administrator in each building and Cafeteria Aides. She reviewed the capacity for each building, students, cafeteria and gym. She noted the district will have a complete QSAC review this year conducted by the New Jersey Department of Education. She will introduce the new staff at the September 11th Board Meeting.

Mr. DeMarco, HIB Coordinator, presented the 2016-2017 HIB School Self-Assessment report, as attached.

Dr. Ruberto thanked teachers for coming in ahead of time to prepare their classrooms and respects the Administrators for being here tonight.

Stacy Cagenello, teacher, loves teaching, she works hard and is in the best environment. She wears a lot of hats. This is a new beginning, work with us not against us. She asked that we settle the contract.

The matters discussed will be made public when confidentiality is no longer required and formal action pursuant to said discussion shall take place only at a meeting to which the public has been invited.

Ms. Voorhees noted they cannot adjourn to Executive Session, they do not have a quorum, however, they will meet as a Committee in Room D111 (no public).

On the motion of Mr. Bart, seconded by Mr. Stager, the meeting was adjourned at 8:45 p.m. viva voce.
