#### SUPERINTENDENT'S REPORT

Mr. Nolan reported on a successful Professional Staff Development Day on September 19<sup>th</sup>. Mr. Nolan observed teachers and administrators developing web pages for our new district website. Teachers were discussing and exploring activities to strengthen their use of Everyday Math and sharing strategies for improving and refining our student's writing skills. Teachers shared with Mr. Nolan their work on Benchmark Assessments and Social Studies teachers were collaborating as they assessed new materials and websites to support the curriculum. Mr. Nolan met with the school nurses to brainstorm the issues and possible steps to address HINI.

Mr. Nolan thanked Mr. Bland, Dr. Carol Baker, Anthony DeMarco, Michele Ritger and Laura Bruhn for their work in planning a day of learning and sharing.

Mr. Nolan also reported that all but one of our schools had held their annual Fall Open House. J. P Case Middle School will host the public tomorrow night. Mr. Nolan stated our school administrators and teachers deserve a great deal of praise for their outstanding work in preparing for this important event.

Mr. Nolan stated that he had included in the board members' packet a letter from Dr. Baker to the K-3 staff informing them of the Rotary Reading with Kids Project.

Mr. Nolan introduced Mr. Bland and Ms. Slagle to provide the Board and the public with important information about the American Recovery and Reinvestment Act (ARRA).

ARRA is an unprecedented opportunity for educators to implement innovative strategies to improve education for at-risk and youth with disabilities, while also stimulating the economy.
